




Measure Physician Variation

Using direct acquisition costing to provide defensible cost measurements, EDS analysis identified significant variability in the average cost of implants across physicians.








Consider Patient Complexity

Severity-Adjusted Analysis

EDS leverages 3M[™] APR-DRG to risk-stratify patients. The resulting severity adjustment accounts for the complexity of each unique patient and sheds light on physician variability. A physician with higher-than-expected costs may treat sicker or more complex patients.






Does process variability impact costs?




Post-Operative Complications

Post-op adverse events, like deep vein thrombosis (DVT), account for thousands of dollars in extended hospitals stays and can impact revenue and reputation.

Using EDS, which embeds ARHQ metrics to identify patient safety and quality indicators, as well as financial impact, promotes more effective risk identification and prevention.




Increased cost of care with DVT complication


