- Efficiently update FTP assumptions around institution and market rates, yield curves, methods, and interest indices in a central web-based location.
- Create specific rules to adjust the base FTP rate for liquidity premiums, options costs, and management spread adjustments to accurately apply funding charges and credits for any product, geographic, or customer account attribute.

- Calculate risk-adjusted return on capital (RAROC) for any dimension through an allocation of economic capital.
- Drive desired behavior by aligning frontline staff with organizational strategies and providing information to incentive compensation plans to support corporate performance.
